# West Hartford Public Schools Capital Improvement Plan for 2023-24 December 20, 2022

The Capital Improvement Plan (CIP) identifies funds needed for the ongoing maintenance of school buildings, new construction, furniture, equipment, and computer infrastructure. The CIP includes a recommended appropriation for fiscal years 2023-24 and 2024-25. Upon approval by of the Board of Education on February 7, 2023, the CIP will be forwarded to the Town Manager for review and incorporation into the Town of West Hartford's Capital Improvement Plan. Following the template of the Town's CIP, the Board's CIP also includes funding recommendations for a total of 12 fiscal years, from 2023-24 through 2034-35. The Town Council will appropriate funding for the 2023-24 and 2024-25 fiscal years of the CIP at its April 25, 2023 meeting.

# 2022-2023 Capital Improvement Plan

Before presenting the proposed CIP for 2023-24 and beyond, it is important to review what occurred with regard to the 2022-23 CIP. The Town Council did not modify the Board of Education's adopted 2022-23 CIP as detailed in Table 1.

We continue to experience limited numbers of bidders, supply chain issues, and escalating construction costs requiring us to adjust project schedules and scopes. However, we were able to accomplish a number of projects in the summer of 2022 as detailed in Table 2.

#### 12 Year CIP Plan 2024-2035

The 12-year CIP plan presented in Table 3 focuses primarily on the continuing investment in maintaining school buildings with recurring projects for building systems (air handlers, electrical switchgear), building envelope (roofs and masonry repairs) and general improvements (flooring replacements, painting, restroom renovations and furniture replacement). It also provides funding for an annual information technology refresh of 1,500 devices.

An additional program enhancement addresses air quality in the elementary schools and began in the 2022-23 fiscal year. The design for the first two projects is nearly complete for Duffy and Webster Hill and due to escalating costs and extended delivery dates for the associated equipment, substantial cost increases and schedule adjustments have been made.

## Planned Projects for Fiscal Years 2023-24, 2024-25 and 2025-26

Planned projects for the next three fiscal years are detailed below by school building:

- Aiken: Restroom Renovations (2024-25)
- ➤ Braeburn: Roof Replacement (2023-24), Parking Lot (2024-25)
- Bugbee: Auditorium Lighting/Sound (2024-25), Restroom Renovations (2024-25), Roof Replacement (2025-26), Fresh Air and Windows (2025-26)
- Conard: Visitor Bleacher Replacement (2023-24), Exterior Door Replacements (2025-26), Air Handler Replacements (2025-26)
- Duffy: Main Entrance Security (2023-24), Fresh Air and Windows (2023-24), Auditorium Lighting/Sound (2024-25), Flooring (2025-26), Painting (2025-26), Paving (2025-26)
- ➤ Hall: Exterior Door Replacements (2023-24), Masonry Repairs (2023-24), Roof Replacement (2024-25), Air Handler Replacements (2024-25)
- King Philip: Flooring (2023-24, 2024-25, 2025-26), Painting (2023-24, 2024-25, 2025-26), Paving (2023-24)
- Norfeldt: Gym Flooring (2023-24), Gym Painting (2023-24)
- Sedgwick: Masonry Repairs (2023-24), Air Handler Replacements (2023-24), Restroom Renovations (2023-24), Exterior Door Replacements (2024-25), Sedgwick Electrical Switchgear Replacement (2025-26)
- Webster Hill: Fresh Air and Windows (2024-25)
